## Modern Slavery Policy Statement

This policy reflects our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place.

All our directors and employees are required to act whenever any concerns are raised either directly within the business or indirectly related to the business.

The company aims to foster a culture that encourages the identification and reporting of any such issues.

- Raise awareness on the topic with employees and the supply chain.
- Update the company Sub Contractor Pre Qualification process to support this policy.
